# ANTI-MCDONALDS DAY IN MEXICO

## A GIFT FOR 10:30AM

On the morning of Oct. 14, in the commercial area of the town of Coacalco in Mexico State, a unit of the Frente de Liberación Animal (FLA), together with the Milicias por los Derechos de lxs Animales [Militias for Animal Rights] (MDA) and anarchist individuals for economic sabotage, left various slogans on the walls of a McDonald's, but not only that, something resembling a time bomb was left at the entrance of that multinational. One of the painted slogans read, 'A gift for 10:30 am' so the manager and other workers quickly called the cowardly local police, the fire brigade, the torturers of the federal police and the violators of the ASE. [Agencia de Seguridad Estatal (state security agency)]

All these bastards were alarmed by the planting of our false bomb, made of putty, wires and a wristwatch, because of it they had to close part of Avenida Lopez Portillo to traffic and the business did not open for a few hours.

All this we did as a response to the extermination of animals

that year after year, day by day and hour after hour, is carried out by those who as humans take an anthropocentric view of other living beings capable of feeling and experiencing pain and subject them to cruel treatment that is seen today as something normal, like the simple fact of eating meat; it was our small but radical response to the ecocide that McDonald's and other multinationals such as KFC, Burger King etc., bring about to acquire more and more capital.

We continue forward in the same way on the international day against McDonalds, because we believe that it does not just depend on a single day to attack this and other multinationals, but that the conflict should be permanent, continuously causing damage through sabotage and direct action.

Similarly, this action was not only for animal liberation and the earth but also for human liberation; we want freedom for our comrades arrested and imprisoned in the confrontation of October 2 in the capital of the country; solidarity should be given to these different fronts,

legally and illegally. Where are all those who call themselves radicals and who boast about social war? It's time to put direct pressure and to attack the fascist state of Calderón, to sabotage the shops who accuse our imprisoned comrades of theft, destroy the institutions that are accomplices of the state, set fire to the police headquarters in different municipalities and states, to take schools, prisons, factories so that the insurgency expands for the freedom of the prisoners.

This time it was only a scare but the next bomb will be truly destructive.

For the liberation of animals, humans and earth, sabotage and subversive direct action! There is no longer room for words in the current situation, now only actions count! We are everywhere!

# MINK FREED ACROSS THE GLOBE

## 1200 FREED IN SWEDEN



On the night of September 16, activists from Djurens Befrielsefront (DBF) in Sweden managed to make a new way into Akes fur farm in Skara, an area with many fur farms. A big hole was cut in the main gate and friends of the animals got in there and into the sheds where the mink were held captive, 3 mink in every little cage. The big hole was soon followed with about 100 small holes in the fence. Several hundred breeding cards were stolen. One of eight sheds were emptied and a total of 1200 mink set free. Only a few minutes after the first cage was opened, the activists witnessed how one mink was already on the other side of the fence, at a nearby river. The animal lovers followed the mink into the forest and to their freedom where they will

continue to follow their natural instincts - to raid Swedens fur farms, one after another. – DBF

## DOUBLE RAIDS IN ITALY

### 9000 RELEASED

The Italian news agency ANSA reported that on September 24 approximately 9,000 mink were released from cages at the Savi fur farm in Conco (Province of Vicenza). The fence was cut in many places. As many as 3,000 of the mink made their way outside of the fence and have not been recovered. An office/storage building at the same farm was destroyed in an arson attack in November 2005.

### 2000 RELEASED

Before dawn on Tuesday, September 30 activists returned to the Anipel fur farm in San Martino Buon Albergo (VR), cut 40 meters of fencing and released 2,000 mink who had been recaptured following a raid a week earlier. Luca Begnini, son of the owner of the farm, told a local newspaper that the family may not be able to continue in the fur business. This farm has been targeted four times in the past two years.

## 6000 RELEASED IN SWEDEN



In the early morning hours of Friday 3rd October as many as 6,000 mink were released from Hulans fur farm outside Svenljunga.

Fencing was cut and surveillance cameras on site were disabled. Ten of the 23 sheds on the farm were emptied of animals.

"Din förlust - deras frihet" ("Your loss - their freedom") was painted on a wall.



The Hulans fur farm was raided once before, in October 1997 when 5,000 mink were released from cages.

## 1500 FREED IN OREGON, USA

In the early morning hours of October 17th, a lone activist infiltrated the fur farm at 92659 Simonsen Road in Astoria Oregon. About 1,500 mink were released from their cages with at least 200 of these being breeding stock. The fact that there is no fence around this farm should help ease their escape. This action is being claimed for the vegan straight edge community, not as a self-congratulatory ego boost, but in the vain hope that it might spur others into action. It has become apparent that the combined tactics of record collecting, sing-alongs, and militant posturing have failed to stop those who abuse innocent life. once we accept this then we can stop squandering our potential and choose a more effective plan of action.

I would like to close by offering a piece of advice to the owners of this farm, to the owners of the other farms in the Astoria, OR area (it was simply by luck of the draw that your farms weren't chosen), and to ALL fur farmers: find a new profession. fur farmers are a dying breed. get out before you are forced out. 'your laws will have no meaning past the setting of the sun.'

# CRACKDOWN ON SHACTIVISTS

## ACTIVISTS RAIDED FOR DROPPING A BANNER

The British Govt's attempts to smash the animal rights movement have long been catalogued in SchNEWS over the years, but this week it turned from the pernicious to the ridiculous as Police stretched their already tenuous use of the word 'blackmail' with regards to animal rights protest...

Last Tuesday (14th) some activists did a banner drop protesting against Ciba Vision, a subsidiary of Novartis, from an overpass over the motorway near Ciba Vision's premises at Hedge End, near Southampton. Ciba Vision make contact lenses, and are a client of vivisection lab Huntingdon Life Sciences (HLS). The protest was just outside the exclusion zone which limits protests near the premises of a list of companies associated with HLS as named on the injunction against SHAC. The two were not arrested, and only had their details taken by police for a possible court summons.

But things turned serious last Friday at 10am, when police kicked the door down at the house they were staying. With a

search warrant regarding Tuesday's banner-drop, 25 coppers arrived - including Hampshire Police's two 'animal rights specialists', Martin Foster and Andrew Tester - and some plain-clothes CID to do the interviewing. The two banner-droppers were arrested for criminal damage and conspiracy to blackmail – because, the police said, they had used spraypaint to make the banner, and that spraypaint had been used in other actions against HLS targets previously! Their clothes were confiscated for forensic analysis, to see if they could be linked to a recent 'home visit' on the manager of a HLS client which involved paintstripper on his car and other nasty surprises. As one of them said, "It's as though police think we're the only people in Hampshire with spray cans".

This was the third time this same household had been raided in the past year, and police also took a computer, owned by another resident, who is currently one of the defendants in the upcoming SHAC trials (see below). A total of six computers, three printers and ten mobile phones have been taken from

this household during these raids.

How can a banner drop in a public place – for all intents and purposes a legal, non-violent action - blow out into a possible charge of 'conspiracy to blackmail'? With the evidence at hand this case would get laughed out of court - that is unless the police try to pin something on them – but this is just the latest chapter in the British Govt's tenacious and heavy handed campaign to smash animal rights activism in this country.

Said one of the arrestees -

"If they take what is legal protest, and use it to arrest people, it forces protesters underground because if they put their faces to actions – even legal ones – they risk having their house raided and being dragged into court cases with possible prison sentences. The Police are the biggest recruiters for the ALF."

"Any animal rights activist saying 'I will continue to protest until they stop' is now seen as tantamount to blackmail. But what is happening to SHAC and other animal rights groups is going to happen to other types of campaigns."

### TRIAL & ERROR

---

Rumbling in the background to this weeks incident is the first of two SHAC trials, which is currently into its third week and is due to last over four months, ending in January. The second trial begins then, but it may be affected by the results of the first. Eight have been charged - two with blackmail and the others with 'conspiracy to blackmail'. Since then, four are on remand and three have pleaded guilty.

But what is all this 'blackmail' thing about? Since 2001 SHAC have published the names of companies doing business with HLS, and initially sent them polite letters saying, 'Do you know what HLS do? Please stop dealing with them.' Since then there have been demos and ALF-style actions against some of them.

It turns out that some of the companies involved did stop working with HLS. Many did so after being visited by police, who told their management that now they were on the SHAC website they needed to beef up security - warning staff of dire threats to life and limb and advising them to check under their cars for bombs. These companies include those



making cages, other torture equipment, and supplying transport and other services to HLS, as well as clients using HLS's 'research' on animals.

The police and prosecution are alleging that, by hosting the names of companies that work with Huntingdon Life Sciences, SHAC are giving a nod and a wink to ALF-style attacks. Yes covert attacks have taken place against HLS related targets – including paintstripper on cars, phonecalls and letters to directors' homes and more – and people have been prosecuted for various offences in the past – but these attacks against HLS (and associated companies) are not being linked to the SHAC defendants in this trial. Instead re-publishing public information and writing to companies about animal abuse inside HLS' labs is made to look like a scene from a Mafia movie where the don says "...we wouldn't want any nasty accidents to happen to you on your way back from the animal murdering lab, would we now."

This trial is just the latest court case involving animal rights activists, coming after the recent Sequani trials which saw Sean Kirtley banged up for four years for running a website. In May 2007 police made 32

arrests across the UK in 'Operation Achilles'. 700 police were involved as homes and animal sanctuaries were raided, with police seizing computers, mobile phones and cash in what a popular weekly direct action newsletter described as a 'fishing expedition'.

But while HLS are being protected by the bootboys and laws of the British state, they are in fact in a tenuous state. They took a loan from the British Govt in 2001, and are battling to repay it. Novartis are being targeted because they are a major client of HLS, which HLS would sorely miss, and their status on the New York Stock Exchange is another weak point for them. If they get kicked off the NYSE before 2011 – as has happened in the past due to the international efforts of SHAC – they will go into liquidation.

That animal rights activists are portrayed in Britain as 'extremists' or 'terrorists' is deeply ironic seeing as they are about protecting animals from torture.

## ARMS FACTORY CLOSED



A mass protest against Brighton-based arms manufacturers EDO MBM/ITT took place on 15th October. Organised by the Smash EDO campaign, the event was the third such demo this year, after the Carnival Against the Arms Trade in June. As the 400-strong march was prevented by police from reaching the EDO factory, 40 bottles of red paint were thrown over the back fence by a group of protesters who split off. The bomb factory was reportedly shut down for the day with at least 10 people arrested and some injured from police violence, including a photographer.
